CANCELLATION POLICY

The reservation form must be sent to the organizer Sportair accompanied by payment of the entire amount including tax. The reservation can only be validated upon receipt of a complete file. Failure to comply with this clause will result in cancellation of participation in the Race Across Festival event. Payments must be made by bank transfer (see RIB on page 1). Delays or non-payments will also result in cancellation of participation in the event.

CANCELLATION CONDITIONS

- 90 to 30 days before the start of the event: 50% cancellation fee
- 30 days before the start of the event: 100% cancellation fees

RESPONSIBILITIES AND COMMITMENTS

The organizer is insured under "Organizer Civil Liability". The organizer undertakes to set up a security guard service at night to ensure the security of the stored material which should in no case be assimilated to entrusted goods. Consequently, the exhibitor is invited to take out the usual "fairs and exhibitions" insurance guarantees with their insurers, i.e. civil liability and "all risks" on their personal and professional effects, objects and materials. The exhibitor undertakes, with its insurers, to waive recourse against the organizer in the event of damage caused or suffered by its effects, objects and professional materials, for any reason whatsoever, including in the event of transport, disappearance, deterioration. The exhibitor must produce a civil liability insurance certificate valid for the entire duration of the event. It will be the exhibitor's responsibility to make a declaration to the police in the event of theft. The exhibitor will then be able to obtain, from the IT system manager, the name, first name and contacts of the person responsible for the theft. The organizer cannot under any circumstances be held responsible for theft. It is up to each exhibitor to complete customs formalities for products coming from abroad.

LIMITATION OF LIABILITY AND CASES OF FORCE MAJEURE

If the event cannot take place, for all or part of its duration, or in the event of force majeure (storm, cataclysm, national strike, fire, etc.), the organizer will not be required to reimburse the sums paid by the exhibitors.

JURISDICTION

Acceptance of the contractual commitment implies compliance with the requirements of this contract and the conditions cited in this reservation form. In the event of a dispute or dispute, the courts of Annecy will have sole jurisdiction.

VALIDITY OF THE CONTRACT

For any reservation request to be taken into account, this contract must be duly completed, signed and validated with the company stamp. If one of the clauses is not respected, the contract cannot be considered valid. Due to the Covid-19 epidemic and any possible mutation thereof, we particularly draw your attention to the fact that the organizer may be required to cancel the Show or postpone it to another date for respond to recommendations from health and government organizations. In such a case, the organizer will immediately notify the exhibitor of its decision to cancel or postpone.
